

Dear Guest,

Welcome to the Kahala Hotel & Resort, Hawaii! We are delighted to have you and your dog as our guests. To ensure a comfortable stay for yourself and fellow guests, we would appreciate it if you would please observe the following guidelines:

- ❖ *By signing this Dog Waiver you agree to a \$150 plus tax dog cleaning fee*
- ❖ The Resort is prepared to accommodate your dog in the room provided that your dog is less than 25 pounds and fully trained, appropriately restrained by you, and that your dog complies with local legislation requirements.
- ❖ Your dog must be kept on a leash when it is in the Resort or on Resort property unless it is in your room.
- ❖ We regret that dogs are not allowed in any food and beverage outlets, CHI Fitness Center and pool areas of the Resort. The exclusion does not apply to guide dogs.
- ❖ You are responsible for cleaning up after your dog on Resort property, and the county of Oahu requires that you do so in the surrounding neighborhoods as well.
- ❖ Any disturbances such as barking must be curtailed to ensure other guests are not inconvenienced.
- ❖ Please contact the Housekeeping Department to arrange for a convenient time of servicing your room as no attempt may be made to enter if there is a dog in the room unless the owner is present.
- ❖ Dog Bowl and Dog Mattress are provided solely for your hotel stay but may be purchased to take home at an additional \$150 each.

You agree to be responsible for all property damages and /or personal injuries resulting from your dog. You further agree to indemnify and hold harmless the Kahala Hotel & Resort and its employees as well as any persons holding a mortgage on the Resort property, the Trustees of the Estate of Bernice Pauahi Bishop, and their respective partners, members, directors, officers, employees, agents, representatives, successors and assigns (collectively, the "Covered Persons") from any and all liability, claims, demands, causes of action, suits, judgments, and costs or fees, including attorneys' fees, for damages of every kind, character and description, including but not limited to, losses caused by the negligence of the Covered Persons, for injuries, death and damages that you may have suffered as a result of or in connection with your dog, and waive all such claims, demands, causes off action, suites, judgments, and costs or fees against any of the Covered Persons for all liability and damage suffered. The Resort reserves the right to charge your account commensurate to the cost of such damage.
